Birthday Party Reservation Agreement and Release Form

PLEASE READ CAREFULLY AND UNDERSTAND THIS DOCUMENT BEFORE SIGNING

This document covers the providing of the facility, the instructor(s) and the birthday lesson horse(s) for riding and instruction of care/grooming by an authorized instructor at **High Tail Acres, LLC** to the person(s) so named on this Agreement, herein after to be referred to as the Customer. The Customer agrees to attend and pay for the provided services. *The Birthday Party fee is *\$350.00.* If your guest list exceeds 12 an additional horse and instructor is required to accommodate your guests. The additional fee is \$50.00. Please limit your number of guests who will be riding to 22.

By signature hereon, High Tail Acres, LLC agrees to:

1. provide the facility.
2. provide the instructor(s).
3. provide the birthday lesson horse(s).
4. provide required SEI certified safety helmet which must be worn by each participant during the time of riding.
5. provide tables and chairs.
6. provide filled piñata.
7. provide "Pin the Tail on the Donkey" game.
8. provide each birthday guest with a coupon toward a free private introductory riding lesson at **High Tail Acres, LLC**.
9. provide Customer with **High Tail Acres, LLC** Release of Liability forms for each participant/guest. Liability forms must be completed and signed by each participant/guest (parent/guardian if guest is a child) upon arrival to the party.
10. provide a second birthday lesson horse for an additional \$50.00 fee, if the number of guests exceeds 12. Please limit your number of guests who will be riding to 22.
11. allow the Customer to arrive one half hour prior to the start of the birthday party to set up.
12. **High Tail Acres, LLC** will clean up.

By signature hereon, the Customer agrees to:

1. **RESERVE YOUR BIRTHDAY PARTY:** please complete, sign and return, with the \$50.00 non-refundable deposit, one copy of this Birthday Party Reservation Agreement and Release Form. If mailed, the customer will receive two(2) forms; please keep one for your information and return the other.
2. pay the balance due prior to the start of your birthday party.
3. provide **High Tail Acres, LLC** with the expected number of all participants/guests prior to the birthday party, so that we may plan accordingly.
4. provide **High Tail Acres, LLC** with signed by all guests (by parent/guardian if participant/guest is a minor) release of liability forms prior to the start of your birthday party.
5. **provide the cake, all refreshments, paper goods, decorations and party favors.**
6. **All Birthday Parties begin at 3:00pm and end at 5:00pm, unless other arrangements are made with High Tail Acres.**

I, the Customer, agree to forever indemnify and hold harmless *High Tail Acres, LLC*, it's owners, employees, instructors, trainers, coaches, assistants, etc. on account of any such claim, except in the case of willful and wanton negligence. I/We, the undersigned, recognize that all equestrian related activities are dangerous, that accidents do happen, that the condition of footing, inside and outside is rarely perfect and that horses oftentimes react to outside stimuli. In light of this knowledge, I/We undertake full responsibility for all harm that may come to ourselves, property, guests, etc.

Any vandalism or disturbances caused by the Customer, or any persons accompanying the Customer, while on the premises of *High Tail Acres, LLC*, will be grounds for immediate termination of this Agreement, and the Customer will be held responsible and liable for any/all damages incurred, including loss of business. It is the responsibility of the Customer to report any/all occurrences to *High Tail Acres, LLC* immediately.

The Customer agrees to forever hold harmless *High Tail Acres, LLC*/ owners, employees, instructors, trainers, coaches, assistants, etc. from any claim caused by horse/pony and agrees to pay legal fees incurred by *High Tail Acres, LLC*/ owners, employees, instructors, trainers, coaches, assistants, etc. in defense of claim, resulting from damage by said horse/pony.
