

LESSON PROGRAM INFORMATION

High Tail Acres, LLC offers private, semi-private and group lessons for beginner, intermediate, advanced, from academy to show horse, for performance and pleasure. The lesson program at High Tail Acres, LLC is individualized to each student, taking into consideration the student's age, ability, previous experience and maturity. The staff at High Tail Acres, LLC stresses the importance of safety and every precaution is taken to provide the student with a positive learning experience. The Sport of Riding requires a commitment, therefore lessons are scheduled on a weekly basis for everyone and more frequently for students in our show and academy programs. Our instructors have received numerous professional awards and are MA licensed each with over 20 years teaching experience. Students in our lesson program have gone on to receive world and national titles, including our apprentice instructor.

LESSON OPTIONS:

- Semi-private Beginner lessons (approximately 30 minutes of riding time). Beginner students are started in semi-private lessons with only beginners in the ring. Beginner lessons will have 2 students/horses in the ring at the same time, with leaders and spotters as needed. Our leaders and spotters are experienced students in our program.
- Semi-private lessons (approximately 30 minutes riding time) allow for instruction with 2 students per instructor in the ring. Semi-private lessons are offered for our intermediate and advanced level students where we will strategically schedule lessons by level of rider's ability and horse availability
- Private lessons (approximately 30 minutes riding time) offer that one on one instruction that allows for the growth and attainment of skills as well as the fine tuning of skills for our students in our show and academy programs.
- Group Lessons (45 minutes of riding time) teach advance ringmanship and strategy skills, while offering the opportunity for students to watch and learn from each other and also create new friendships with other horse lovers in the barn. Group lessons are by invitation only and are reserved for students in our academy and show programs.

EQUIPMENT REQUIRED:

Students are required to wear ASTM/SEI certified protective headgear. Hard-soled shoes or boots (not cowboy boots) with at least, but not more than, a ½ inch heel are required footwear. Students should wear long pants to prevent chafing. For the student's initial lessons, High Tail Acres has available helmets and boots for student use.

Upon completion of a student's 2nd lesson package, we require the student to purchase their own helmet, boots, jodhpurs and gloves. The staff at *High Tail Acres, LLC* will assist you in ordering and or providing a location from where you can purchase the correct riding apparel and equipment.
